
With reference to your application and on the basis of subsequent correspondence with the school/inspection of the school,

I, the Education Officer (Primary), Zilla Parishad, Aurangabad hereby granting approval to **New Primary (6th 12th Standards) of English Medium School of Vasant Rao Naik Shikshan Prasarak Mandal, Aurangabad's V.R. Scholarden School, CIDCO, N-9, Aurangabad for Standard 7th to 8th from the academic years 2019-20 up to 31st March, 2022** on self finance basis under section 4 of the Right of Children to Free and Compulsory Education Rules, 2011, subject to Government Resolutions under reference and Inspection report.

The above approval/recognition is subject to fulfillment of following conditions:-


1. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Maharashtra Right to Children to free and Compulsory Education Rules, 2011(Annexure II).
2. The school shall admit in 1st Standard, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide them free and compulsory primary education till its completion. Provided further that this ratio shall also be followed in case of pre-primary classes.
3. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements, school shall provide a separate bank account.
4. The society/school shall not collect any capitation fee and subject the child or his her parents or guardians to any screening procedure.

5. The school shall not deny admission to any child for lack of age proof, on the ground of religion, caste or race, place of birth or any of them.
6. (One) The school shall ensure that no child who is given admission shall be held back in any class or expelled from school till the completion of elementary in the school;
- (Two) No child shall be subjugated to physical punishment or mental harassment;
- (Three) No child is required to pass any board examination till the completion of primary education;
- (Four) Every child who has completed primary education shall be awarded a certificate as laid down under Rule 23;
- (Five) Handicapped/ students with special needs be included under the provisions of the Act.
- (Six) The teachers shall be recruited with minimum qualifications as laid under section 23(1) of the Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
- (Seven) The teacher perform shall perform his or her duties specified under section 24(1) of the Act and
- (Eight) The teachers shall not engage himself or herself for private teaching activities. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
7. The school shall enroll students proportionate to the facilities available in the school as prescribed in section 19 of the Act.






