



Terms and conditions:

- (1) The school is required to comply with the provisions of the Right to Free and Compulsory Education Act, 2009 and all the rules/provisions prescribed there under from time to time.
- (2) On complying with the provisions of the Act, 2009 by the School management, Permission (letter of intent) is being given to start School in the academic year 2020-21 as follows.
 - (A) If the management is complying with all provisions required as per prescribed Rules of the Government for establishment of School, then the management shall submit application for first approval **within one month** from the commencement of academic year before the concerned District Education Officer.

(B) Since the Management has been considered eligible as per this Government Resolution for the academic year 2019-20, in case all the things required as per prescribed Government Rules are not available, then it will be binding upon them to start the school within **eighteen months** from the date of this Government Resolution by complying the said provisions, else the permission granted shall **stand cancelled** automatically.


(3) It will be **binding** upon New school to which permission is granted to comply complying with i) procedures and orders issued by the Government from time to time so also provisions of (ii) Maharashtra Self Financed Schools (Establishment and Regulation) Act, 2012 (1 of 2013).

(4) Concerned competent officer shall ensure about compliance of provisions of the Act, 2009 and then only shall take further action for grant of **first approval**.

(5) No any change can be made in future in the medium of school and place of school etc. demanded for permission by the Society for permission of school. In case the school is started at any other place than the place for which permission has been granted by the Government to start school, then the permission

granted by the Government shall **stand cancelled** automatically.


