
Government Resolution:

2.1 Permission is hereby granted to V. R. Scholar Den School, Aurangabad run by Vasantao Naik Shikshan Prasarak Mandal, Aurangabad under the Maharashtra Self Financed Schools (Establishment and Regulation) Act, 2012 (1 of 2013) for up-gradation/ Start (In continuation of primary school- Upper Primary to Higher Secondary School, Standard 6th 12th, all branches, English Medium, up-gradation, State Board) from the academic years 2019-20 subject to compliance of following terms and conditions:


2.2 Terms and conditions:

The concerned Divisional Deputy Director of Education shall ensure that the proposed school has not been started prior to

grant permission by the Government. However, in case the said school has been started before obtaining permission of the Government, then the concerned Divisional Deputy Director of Education shall recover fine of Rs. One lakh from the said school and submit his report to the Government. Similarly it is necessary to submit up to date certificate of bank balance of Rs. one lakh, RTE Form No.2 Certificate for Standards 1st to 5th, School, Approval order for Standards 1st to 5th and photographs of basic facilities required as per provisions of RTE Act, 2009 (i.e. Computer section, Laboratory, separate toilets for boys and girls, adequate water facility, necessary class rooms, playground, etc.) to the concerned Divisional Deputy Director of Education within three months. If these things are not complied with, then approval of the said school shall be treated as automatically cancelled.

- (2) The school is required to comply with the provisions of the Right to Free and Compulsory Education Act, 2009 and all the rules/provisions prescribed thereunder from time to time.
- (3) On complying with the provisions of the Act, 2009 by the School management, Permission (letter of intent) is being given to start School in the academic year 2020-21 as follows.

(A) If the management is complying with all provisions required as per prescribed Rules of the Government for establishment of School, then the management shall

submit application for first approval within one month from the commencement of academic year before the concerned District Education Officer.


(B) Since the Management has been considered eligible as per this Government Resolution for the academic year 2019-20, in case all the things required as per prescribed Government Rules are not available, then it will be binding upon them to start the school within 18 months from the date of this Government Resolution by complying the said provisions, else the permission granted shall stand cancelled automatically.

(4) It will be binding upon New school to which permission is granted to comply complying with i) procedures and orders issued by the Government from time to time so also provisions of (ii) Maharashtra Self Financed Schools (Establishment and Regulation) Act, 2012 (1 of 2013).

(5) Concerned competent officer shall ensure about compliance of provisions of the Act, 2009 and then only shall take further action for grant of first approval.

(6) No any change can be made in future in the medium of school and place of school etc. demanded for permission by the Society for permission of school. In case the school is started at any other place than the place for which permission has been granted by the Government to start school, then the permission granted by the Government shall stand cancelled automatically.

(7) U-DISE Data:- While filling in information regarding new school/up-

graded school permitted under this Government Resolution in District wise U-Dise (Unified District Information System for Education), responsibility about obtaining U-DISE Number, by noting in independent category as " School Permitted on Self Finance Basis", will be on the concerned Society. For further action in this regard, the State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as Nodal Officer. Similarly, for the purpose of information to all concerned, Society display a board as "Self Financed Basis New/ Upgraded School" on the entry gate out side the school.

- (8) Recruitment of teaching and non teaching staff in the self finance basis permitted school shall be made as per the prevailing rules and policy of the Government.
3. Responsibility to communicate this order to the concerned society within fifteen days will be on the concerned Divisional Deputy Director of Education.
